**JOINT HEARING MANAGEMENT PLAN IN COMPLIANCE WITH ASSIGNED  
COMMISSIONER’S SCOPING MEMO**

Pursuant to the Assigned Commissioner’s Ruling and Scoping Memo, dated October 12, 2011, Southern California Edison Company (“SCE”) respectfully submits this joint management plan for the hearing. As directed by the Scoping Memo, SCE contacted Complainant Verlyn Roschewski (“Mr. Roschewski”) to develop the hearing management plan. During our discussion on November 14, 2011, Mr. Roschewski stated that he plans to serve as his only witness. SCE informed Mr. Roschewski that it plans to offer one witness who can testify regarding the bills at issue. Mr. Roschewski stated that he would like to ask SCE’s witness some questions, but did not express a preference for the order of testimony or an estimate of time for his cross examination.

Given that the Assigned Commissioner scheduled the November 18, 2011, hearing for two hours, SCE proposes the following order of witnesses and time for cross-examination. SCE believes the proposed cross examination times are reasonable to allow sufficient time for direct

testimony and any additional matters Administrative Law Judge Kenney plans to address during the hearing.
