Pursuant to Article 8 of the California Public Utilities Commission's Rule of Practice and Procedure, the Division of Ratepayer Advocates ("DRA") files this Notice of an *ex parte* communication.

On March 9, 2010, at approximately 10 am, DRA representatives Danilo Sanchez, Water Branch Manager, and Lisa Bilir, Public Utility Regulatory Analyst V, DRA Water Branch, met with Sepideh Khosrowjah, Chief of Staff to Commissioner Ryan at the Commission's headquarters in San Francisco. The meeting lasted approximately 30 minutes. During the meeting, DRA presented and discussed two documents. The first is a one page summary of DRA's position regarding the Proposed Decision ("PD"), attached to this notice. DRA discussed the bullet points of the one-page summary, including its general support of the PD, and its proposed modifications. DRA also presented and discussed its January 21, 2010 filed comments titled "Comments Of The
