Pursuant to Rule 8.3 of the California Public Utilities Commission's (Commission or CPUC) Rules of Practice and Procedure, the Division of Ratepayer Advocates (DRA), the Consumer Protection and Safety Division (CPSD), and Disability Rights Advocates (DisabRA) hereby submit notice of the following *ex parte* communication in the above referenced proceeding. On Monday, September 27, 2010 at 4:00 PM, Jack Stoddard, attorney for DRA, Nicholas Sher, attorney for CPSD, and Melissa Kasnitz and Karla Gilbride, attorneys for DisabRA, met with Commissioner Nancy Ryan and her advisor, Jason Reiger, in Room 5209 at the CPUC for thirty minutes. The meeting was requested by Mr. Stoddard as an equal time meeting pursuant to Rule 8.2(c)(2) of the Commission's Rules of Practice and Procedure. Southern California Edison Company, Pacific Gas & Electric Company, San Diego Gas & Electric Company, and Southern California Gas Company triggered the equal time requirement for proceeding A.09-08-020 when their representatives met with Commissioner Ryan on September 8, 2010.

Attorneys for DRA, CPSD, and DisabRA collectively stated their opposition to A.09-08-020 and summarized the issues raised in their protests. No documents were distributed.
