**NOTICE OF EX PARTE COMMUNICATION OF THE MONTEREY
PENINSULA WATER MANAGEMENT DISTRICT**

Pursuant to Article 8 of the California Public Utilities Commission’s Rule of Practice and Procedure, the Monterey Peninsula Water Management District (“MPWMD”) files this Notice of *ex parte* communication.

On November 10, 2010, MPWMD Chair Regina Doyle, MPWMD Vice Chair Bob Brower, MPWMD General Manager Darby Fuerst and MPWMD General Counsel David C. Laredo met with Matthew Tisdale, Advisor to Commissioner Dian M. Grueneich, at the California Public Utilities Commission offices in San Francisco, California. The meeting convened at 10:00 a.m. The MPWMD requested the meeting; the meeting lasted one half hour. No materials were presented.

The group discussed the Proposed Decision and the Alternate Proposed Decision related to the Regional Water Project. MPWMD stated its concern regarding the composition of the advisory committee and the voting status of its members. Concern was stated regarding the fact that no municipal representative was allowed for the City of Monterey or for the unincorporated areas on Pebble Beach, Carmel Valley and other areas. MPWMD stated its concern as to the Alternate Proposed Decision discussion of

fees limit and the proposed language requiring the Marina Coast Water District to contribute to future connection charges. The Chair discussed the District's role and the legislation creating the District. The group discussed project alternatives as listed in the EIR. The group discussed the Commission calendar, the possible setting of a Rate Setting Deliberative Meeting and the rules of procedure related to such an action.

Questions were asked by Mr. Tisdale as to the status of matter 10-05-020 (Moratorium) and how it was influenced by the 2009 State Water Resources Control Board's Cease and Desist Order.
