**NOTICE OF *EX PARTE* COMMUNICATION  
OF PACIFIC GAS AND ELECTRIC COMPANY**

Pursuant to Rule 8.3(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following ex parte communication. The communication occurred via telephone on Friday, December 10, 2010, at approximately 2:00 p.m. to the offices of the California Public Utilities Commission in San Francisco. The communication was oral and no handout was provided. [Rule 8.3(a)]

John Hughes, Director- Regulatory Relations, PG&E, initiated the communication with Scott Murtishaw (Advisor to Commission President Michael R. Peevey). [Rule 8.3(b)]

The purpose of the call was to answer a question about how any salvage value is treated in connection with the electromechanical meters that are replaced by the smart meters. Mr. Hughes left a voice mail message that basically stated that any proceeds from disposing of the electromechanical meters are recorded in the Smart Meter balancing account (SBA). He further stated that removal costs are also recorded in the SBA and that those costs are much greater than

the salvage value received. For example, the total salvage value recorded in the SBA for 2009 was only \$435,000. [Rule 8.3(c)]
