NOTICE OF EX PARTE COMMUNICATION

Pursuant to Rule 8.3 of the Commission’s Rules of Practice and Procedure Dwight Nelson (“Mr. Nelson”), interested party in the above-captioned matter hereby files the following Notice of Ex Parte Communication.

On February 2, 2011, Thomas J. MacBride, Jr., counsel for Mr. Nelson, met with Lester Wong, Water Advisor to President Peevey. The meeting occurred at 9:45 a.m. the Commission’s offices in San Francisco and lasted approximately 15 minutes. No other persons participated in the meeting.

During the course of the meeting, Mr. MacBride described Decision No. 11-01-029 the recent order granting rehearing of D. 09-11-008. Mr. MacBride stated his view that the Commission possessed the jurisdiction to grant the relief requested in the above-captioned application and requested that the Commission give serious consideration to approving a settlement if one was presented to it.

Mr. MacBride noted that Mr. Nelson cooperated with the Commission Staff to bring to fruition the sale of a contaminated water company to Cal Water Service— an entity able to provide safe and adequate service to the public. Mr. MacBride noted that Mr. Nelson simply sought the repayment described in two Commission orders for which he has now waited 24 years.
