LATE-FIELD NOTICE OF EX PARTE COMMUNICATION

Pursuant to Rule 8.3 of the Commission's Rules of Practice and Procedure, The Utility Reform Network (TURN) hereby gives notice of the following *ex parte* communication. On April 11, 2011, TURN attorney Matthew Freedman met with Scott Murtishaw, advisor to Commissioner Michael Peevey. The meeting was initiated by TURN attorney Matthew Freedman, occurred at 505 Van Ness Avenue in San Francisco in Mr. Murtishaw's office, began at 10am and lasted approximately two hours.

Mr. Freedman discussed TURN's concerns about the Alternate Decision of Commissioner Peevey on PG&E residential rate design issues. Mr. Freedman explained that the proposal for a fixed residential customer charge would violate state law, disproportionately impacts lower-usage customers, and is contrary to the goal of promoting conservation. Mr. Freedman further explained that the Peevey alternate sends the wrong message to customers, will provoke additional customer anger, and is susceptible to a legal challenge as explained in the testimony of former TURN senior attorney (and now Commissioner) Mike Florio. Mr. Freedman urged Commissioner Peevey to withdraw his alternate and support a modified version of the Proposed Decision of ALJ Pulsifer. No written materials were provided by TURN.
