**I. INTRODUCTION**

Pursuant to assigned Administrative Law Judge Wilson’s e-mail dated July 6, 2010 11:01 a.m., and in accordance with Rule 13.8, subdivision (d) of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure (“Rule”), the parties stated below<sup>1</sup> move to admit in evidence their respectively written, prepared testimonies and related witnesses’ declarations. In accordance with Rule 11.5, subdivision (b), the Parties are also concurrently filing another All-Party Motion to seal portions of the evidentiary record in this proceeding.

The Parties are as follows:

- PacifiCorp, d.b.a. Pacific Power (“PacifiCorp”);
- California Farm Bureau Federation (“CFBF”); and
- Division of Ratepayer Advocates (“DRA”).

## **II. THE SUPPORT FOR THIS MOTION**

According to Rule 13.8(d) in pertinent part, prepared testimony may be offered into evidence by written motion in a proceeding in which it is preliminarily determined that a hearing is not needed; the proceeding was initiated by application; and no timely answer or response is filed. On November 20, 2009, PacifiCorp filed its general rate case application (“Application”), which DRA protested on December 23, 2009. Subsequently, each Party served its prepared testimonies on the other Parties in compliance with the proceeding’s adopted schedule and before the date of the scheduled hearing.<sup>3</sup>

In lieu of answering or otherwise responding, on June 23, 2010, PacifiCorp joined with the other Parties in filing an All-Party Joint Motion for Commission Approval and Adoption of a Settlement Agreement (as attached thereto). Subsequently, at the Parties’ request, the assigned ALJ Wilson removed the scheduled hearing from the Commission’s Calendar.

In an e-mail dated July 6, 2010, ALJ Wilson directed the Parties to concurrently file two Joint Motions: (i) one under Rule 13.8(d) requesting admitting in evidence the Parties’ respectively written, prepared testimonies; and (ii) another under Rule 11.5(b) asking to seal portions of the evidentiary record. The ALJ also requested that each Party’s witnesses submit a declaration in support of their respective testimonies. This All-Party Motion complies with ALJ Wilson’s directions stated above, meets the prerequisites of Rule 13.8(d), and merits Commission approval.
