Pursuant to Rule 13.13 of the Commission’s Rules of Practice and Procedure, San Pablo Bay Pipeline Company, LLC (“San Pablo Bay”), applicant in the subject, consolidated proceedings, requests an opportunity, as is its right, to make a final oral argument before the Commission. These proceedings, in which hearings were held, are all categorized as ratesetting, including complaint cases challenging the reasonableness of rates that are categorized as ratesetting in accordance with Commission Rule 1.3(e). No time limit has been set, either by a scoping ruling or later ruling that precludes the granting of San Pablo Bay’s request.

The Proposed Decision (“PD”) issued in these proceedings on March 9, 2011 addresses and resolves matters of extraordinary significance to San Pablo Bay, involving millions of dollars in potential refunds and rate reductions and terms of service that bear directly upon San Pablo Bay’s ability to maintain safe and reliable pipeline transportation services in California. Necessarily, San Pablo Bay hereby exercises its right to request oral argument before the Commission.
