**SOUTHERN CALIFORNIA EDISON COMPANY’S (U 338-E) THIRD SUPPLEMENT
TO WORK PAPERS IN COMPLIANCE WITH ASSIGNED COMMISSIONER’S
SCOPING MEMO**

Pursuant to assigned Administrative Law Judge (ALJ) Kenney’s Email dated November 17, 2011, requesting follow-up information to SCE’s Second Supplement to Work Papers in Compliance with Assigned Commissioner’s Scoping Memo, filed October 26, 2011 (“ALJ’s Email Request”), SCE respectfully submits the following responses and corrected versions of Attachments B-9 and B-11.

Reference to Attachments A-1 through A-7, B-1 through B-7, C-1 through C-7, D-1 through D-7, and E-1 through E-7, are references to the Attachments to SCE’s Work Papers in Compliance with Assigned Commissioner’s Scoping Memo, filed October 14, 2011, unless otherwise indicated.

Reference to Attachments A-8 through A-11 and B-8 through B-11 are references to the Attachments to SCE’s Second Supplement to Work Papers in Compliance with Assigned Commissioner’s Scoping Memo, filed October 26, 2011, unless otherwise indicated.

ALJ Kenney expressed a concern that SCE did not provide copies of the re-bills referenced in Attachment B-8. Unfortunately SCE does not have copies of these re-bills, as they were sent to the customer approximately eight years ago. SCE's witness will be available to testify to the re-bills and SCE's record system showing the adjustments should ALJ Kenney wish to raise this issue at the evidentiary hearing on November 18, 2011.

Pursuant to the ALJ's Email Request, SCE submits revised versions of Attachments B-9 and B-11 to correct some calculation and labeling errors in the spreadsheets. SCE's witness will also be available to explain these corrections should questions arise at the evidentiary hearing.
