**REVISED SCOPING MEMO AND RULING OF THE
ASSIGNED COMMISSIONER AND ADMINISTRATIVE LAW JUDGE**

1. Summary

Pursuant to Rule 7.3 of the Commission's Rules of Practice and Procedure,¹ following a prehearing conference held on October 4, 2011, this ruling revises the *Preliminary Scoping Memo* as to the schedule of this proceeding, which was included in Rulemaking 11-03-007, issued March 10, 2011. The *Preliminary Scoping Memo* addressed the scope of this proceeding and other procedural matters and set forth the procedural schedule.

2. Proceeding Schedule
