**ADMINISTRATIVE LAW JUDGE'S RULING GRANTING
THE MOTION FOR PARTY STATUS FILED BY GWF ENERGY LLC**

This ruling grants the motion for party status filed by GWF Energy LLC.

Background

On December 14, 2009, GWF Energy LLC (GWF) filed a motion for party status pursuant to Rule 1.4(a)(4) of the Commission's Rules of Practice and Procedure (Rule). In its motion, GWF states that it has an interest in this proceeding because of its status as the counterparty to the five contracts that Pacific Gas and Electric Company has submitted for Commission approval in this proceeding. GWF intends to participate in this proceeding for the purpose of advancing several factual, legal, and policy contentions as to why the Commission should approve the five contracts.
