1. Notice

2. PHC statements

In order to make the PHC more productive, both the applicant and the Division of Ratepayer Advocates, the two parties to this proceeding, are required to file and serve PHC statements of no more than 10 pages no later than

Thursday, March 25, 2010. The PHC statements should identify the issues to be addressed in this proceeding and propose a schedule for the proceeding. If any party believes that evidentiary hearings may be necessary, the reasons for evidentiary hearings should be included in the PHC statement.

The parties are encouraged but not required to confer prior to the PHC.

2. Parties shall serve and file PHC statements of not more than 10 pages addressing the topics set forth above no later than March 25, 2010.
