**ADMINISTRATIVE LAW JUDGE'S RULING SUBSTITUTING  
REPLACEMENT VERSION OF PROPOSED DECISION**

On May 25, 2010, Administrative Law Judge Darwin E. Farrar issued a Proposed Decision in this proceeding. Information which Pacific Gas and Electric Company (PG&E) deems confidential was inadvertently included in the version of the Proposed Decision that was posted on the Commission's website.

This ruling directs that the Proposed Decision that was originally posted on the Commission's website be removed and replaced by a version of the Proposed Decision that does not contain purportedly confidential information. The replacement version of the Proposed Decision shall be identified as the "Replacement Proposed Decision."

This ruling further directs that parties that have reviewed and/or printed the original version of the Proposed Decision shall disregard and/or destroy that document and continue to treat the information as confidential, and subject to the nondisclosure agreement. As this substitution is being made prior to the mailing of the Notice of Availability, only the replacement version of the Notice of Availability will be sent by U.S. mail.

The time for comments and replies to the Replacement Proposed Decision is set forth in the Chief Administrative Law Judge's May 26, 2010 cover letter attached to the Replacement Proposed Decision.

**IT IS RULED** that:

1. The version of the Proposed Decision issued in this proceeding that was posted on Commission's website on May 25, 2010, shall be removed and replaced with a replacement version.
2. Parties that have reviewed and/or printed the version of the Proposed Decision that was originally posted on the Commission's website shall disregard and/or destroy that document and continue to treat the information as confidential and subject to the nondisclosure agreement.
3. The replacement version of the Proposed Decision shall be identified as the "Replacement Proposed Decision," and posted on the Commission's website.
4. Only the Replacement Notice of Availability will be sent by U.S. mail.
5. The time for comments and replies to the Replacement Proposed Decision is set forth in the Chief Administrative Law Judge's May 26, 2010 cover letter attached to the Replacement Proposed Decision.
