WilTel Communications, LLC ("WilTel") filed its Application To Amend Its Certificate of Public Convenience and Necessity on an Interim Basis and Request for Expedited Ex Parte Relief, A.04-05-017 on May 3, 2004 and supplement to A.04-05-017 on July 9, 2004 ("Application"). Based on recent discussions with staff, WilTel determined that it should file a Second Supplement to its Application to modify its request for relief. Specifically, WilTel will modify its request for relief to adopt programmatic mitigated negative declarations ("PND") previously issued by the Commission. 
