The California Public Utilities Commission (CPUC) has scheduled Evidentiary Hearings (EH) for Phase 2 of the consolidated Smart Meter Opt Out proceeding listed above. The dates, times and locations of the EHs are noted below.

Any changes to dates, times and location of the EHs will be posted to the CPUC's Daily Calendar. Locations for these hearings are wheelchair accessible. If you are in need of special accommodations such as assisted listening devices or translation services, please contact the Public Advisor's Office at the toll free number or email noted below 3 – 5 days prior to the hearings.

The purpose of the EHs is to have an Administrative Law Judge (ALJ) preside over the administrative review and examination of evidence related to the proposed costs, cost recovery and cost allocation in Phase 2 of the consolidated Smart Meter Opt Out proceeding, including those of Southern California Gas Company (SoCalGas).

SoCalGas' cost proposal presented in SoCalGas' testimony provides the following:

SoCalGas is requesting cost recovery for all incremental costs associated with smart meter opt out, and that all costs be allocated to those customers who opt out.

The impact on each customer and each customer class could vary depending on CPUC's final decision.

EVIDENTIARY HEARINGS

Evidentiary hearings will be held at the designated CPUC hearing room in San Francisco, CA at the dates, times and locations noted above. The CPUC holds EH's whereby the formal parties of record provide testimony and are subject to cross-examination before the CPUC's assigned ALJ. These hearings are open to the public to attend and listen, but only those who are formal parties of record are allowed to participate. The Division of Ratepayer Advocates (DRA), which consists of engineers, accountants, economists and attorneys independently evaluate the proposals of the utilities and present their analysis and recommendations for the CPUC at the EH's. The CPUC has its own court reporters who will record the participation of parties in the EH's. Parties may offer proposals that differ from those presented in the cost proposal presented in SoCalGas' testimony. Once hearings are completed, the ALJ will consider all of the evidence presented and release a proposed draft decision. When the CPUC issues a final decision, it may adopt, amend or modify all or part of the ALJ's proposed decision. The final decision may differ from the requests filed by SoCalGas in its opt out cost proposal supported by the testimony.
