**Prehearing Conference Statements**

A prehearing conference statement may be filed by any person, limited to addressing the following questions:

1. whether there is any objection to the categorization of the proceeding;
2. whether we should adopt or modify the proposed schedule for Phase I of this proceeding; and,
3. what form administrator filings should take for 2015 portfolio funding.

We anticipate a large number of parties will participate in this proceeding. To keep prehearing conference statements concise, we will restrict the length of prehearing conference statements to 6 pages (including caption and signature block).

The service list in this proceeding is still being developed. Accordingly, this notice and ruling as well as prehearing conference statements, should be served on the service list in R.09-11-014, the predecessor energy efficiency rulemaking.

Therefore, **IT IS RULED** that:

1. A prehearing conference in the above-entitled proceeding shall be held on December 11, 2013, at 9:00 a.m., at the CPUC’s Hearing Room A, 505 Van Ness Avenue, San Francisco.
2. Any person may file a prehearing conference statement with the CPUC’s Docket Office on or before December 6, 2013. The prehearing conference

statement or objection shall be served on the service list in Rulemaking 09-11-014 as well as on the service list in this proceeding.

3. Any “customer” who intends to seek an award of intervenor compensation in this proceeding shall file and serve on all parties to this proceeding a notice of intent to claim compensation within 30 days after the prehearing conference is held in this proceeding.

4. Parties desiring expedited or daily transcripts should advise the Chief Hearing Reporter by telephone at (415) 703-2288, no later than three days prior to the first day of hearing.
