Calpine’s proposed corrections will ensure that all references in the transcript to the exhibit “February 6, 2014 Exceptional Dispatch CPM Designation Report and Capacity Procurement Mechanism Designations Issued 9/8/11” are to Calpine-08.

² Due to the proposed correction explained in footnote 1, this portion of the transcript would no longer be necessary and should be deleted, as it suggests that Calpine-05 has not been entered into the record. We note that the original Calpine-05 is the “CAISO 2013 Annual Report on Market Issues and Performance” that was, in fact, identified on page 3516 at lines 17-20 and entered into the record on page 3581 at lines 19-23.


