**TO PARTIES IN A.16-05-001 and Others on the Official Address List:**

In an August 26, 2016 email, counsel for SCE informed me that: *“The DA Parties agree to withdraw their testimony, which would obviate the need for SCE to submit rebuttal testimony on the issues raised in that testimony on August 26th. (This is the same agreement that the DA Parties recently reached with SDG&E in that utility’s pending ERRa proceeding). SCE and LCE have met and conferred, and agree that while SCE will submit rebuttal testimony on August 26th, SCE and LCE hope to submit a stipulation within a week that would resolve the issue raised in LCE’s testimony.”*

To date, I have not received any stipulations from the parties. Therefore, I have set a telephonic conference on September 20, 2016 @ 2 p.m. for the purpose of determining whether parties will resolve disputes without need of evidentiary hearings. All parties are advised to participate using the call information below.
