Dear Laura,

Thank you for responding; sorry it took me so long to reply. Union of Concerned Scientists (UCS) asserts it is eligible under §1802(b)(1)(C) as an organization authorized to represent the interests of residential customers. Your organization's Notice of Intent to Claim Intervenor Compensation (NOI) also indicates that UCS is an environmental organization (environmental groups may be eligible under § 1802(b)(1)(C) as representing residential customers who have a concern for the environment (D.98-04-059 fn. 14 at 30)).

Section 1802(b)(1)(C) organizations must provide a copy of articles of incorporation or bylaws. Would it be possible for UCS to file copies of the articles of incorporation and bylaws formally, in R.16-02-007, as attachments to the amended NOI, within 30 days of this request? The amended NOI must also point out where these documents contain a specific authorization to represent the interests of residential customers or to represent environmental concerns of the customers (see D.98-04-059 at 31-32).
