NOTICE OF EX PARTE COMMUNICATION

Pursuant to Rules 8.3 and 8.4 of the California Public Utilities Commission's ("Commission") Rules of Practice and Procedure, California-American Water Company ("Cal Am"), provides notice of ex parte communication. On June 22, 2016, an All-Party Meeting was held. The All Party Meeting began at 1:30 p.m. and lasted approximately 25 minutes. In attendance were: Commissioner Liane Randolph; Commissioner Randolph's Chief-of-Staff, Rachel Peterson; Commissioner Randolph's Water Advisor, Lester Wong; David Stoldt, General Manager of the Monterey Peninsula Water Management District (MPWMD); David Laredo, General Counsel for MPWMD; Thomas J. MacBride, Jr., counsel for MPWMD; Ting-Pong Yuen and Marcelo Poirier, on behalf of the Office of Ratepayer Advocates; Jeffrey Linam, Director of Rates for Cal Am; and Nicholas Subias, Corporate Counsel for Cal Am.

During the meeting, the background and impact of the California Supreme Court's January 25, 2016 decision (S208838) in connection with Cal. P.U.C. Decision Nos. 11-03-035 and 13-01-040 was discussed. This concerned an MPWMD user fee placed on Cal Am bills. Cal Am addressed certain questions on the process for moving

forward in light of the Supreme Court’s Ruling, so the user fee could again appear on Cal Am bills. Specifically, Cal Am discussed issues relating to notice, tariffs, and billing. Cal Am used a table to discuss proposed payment priority rules. That table is attached hereto as “Attachment A.”
