**EX PARTE NOTICE OF THE NATURAL RESOURCES DEFENSE COUNCIL (NRDC)  
AND CALIFORNIA HOUSING PARTNERSHIP COPORATION (CHPC)**

In accordance with Rules 8.2, 8.3 and 8.5 of the California Public Utilities Commission (Commission) Rules of Practice and Procedure, the Natural Resources Defense Council (NRDC) and the California Housing Partnership (CHPC) respectfully submit this notice of the following ex parte communication in the above-captioned proceeding. NRDC and CHPC jointly requested this meeting to discuss the 2015-2017 Energy Savings Assistance program.

On August 29, 2016, from approximately 1 PM to 2 PM, Maria Stamas for NRDC, Ann Gressani for CHPC. and Caroline McCormack of CHPC spoke with Michael Colvin, advisor to Commissioner Sandoval at the Commission's offices in San Francisco: 505 Van Ness Avenue, San Francisco, CA, 94102.

On August 30, 2016, from approximately 11:30 to 12 PM Maria Stamas, Caroline McCormack, and Ann Gressani spoke with Jennifer Kalafut, advisor to Commissioner Peterman, and from approximately 1 PM to 1:30 PM, Maria Stamas, Caroline McCormack, and Ann Gressani spoke with Sean Simon, advisor to Commissioner Randolph at the Commission's offices in San Francisco: 505 Van Ness Avenue, San Francisco, CA, 94102.

All communications regarded the proposed and alternate decisions of the investor-owned utilities for the Energy Savings Assistance Program and NRDC, CHPC, and National Consumer Law Center's joint recommendations for increasing energy savings and participation of eligible customers living in multifamily housing. Ms. Stamas and Ms. Gressani expressed their

organizations' support for the Alternate Proposed Decision, with minor modifications. They asked questions seeking clarification on the funding allocations and mechanisms in the APD and the recommendations concerning how the multifamily program would be administered. They also expressed their support for an interim energy savings goal as adopted by the APD, but noted that the specific targets required upward adjustment because some of the utility-specific energy targets were lower than those proposed in utilities' 2015-2017 applications. They also suggested that the Commission adopt an interim adjusted-ESACET cost-effectiveness threshold that would apply for post-2020 applications.
