Subject: A1706006 Email Ruling Suspending Procedural Schedule

The procedural schedule for Application (A.) 1706006 is suspended. Parties have indicated that a settlement has been reached and request time to finalize settlement documents.

A Ruling was issued on January 9, 2018 directing parties to provide witness cross-examination estimates and a list of disputed facts by noon on January 12, 2018. On January 10, 2018, San Diego Gas & Electric Company (SDG&E) sent an email to the Administrative Law Judge and the service list stating that SDG&E and the Office of Ratepayer Advocates (ORA) “have had extensive, confidential settlement discussions in an effort to resolve all issues in dispute in this proceeding” and requested an extension until January 17, 2018 to provide the cross-examination estimates and list of disputed facts. On January 11, 2018, ORA sent an email to the Administrative Law Judge and the service list stating that SDG&E and ORA have “finalized the settlement terms” and requested suspension of: 1) cross-examination estimates and list of disputed facts submission; and 2) the hearing dates scheduled for January 23-26 of 2018.

Suspension of the procedural schedule for A.1706006 will provide the parties time to prepare the formal settlement documents. The request to suspend the procedural schedule is reasonable and should be granted.

IT IS RULED that the procedural schedule for Application 17-06-006 is suspended to allow parties to finalize formal settlement documents.

The Docket Office shall formally file this Email Ruling.
