Subject: R.17-06-026: E-Mail Ruling shortening time to respond to February 7,
2018 Joint Motion

To the service list in R.17-06-026:

On February 7, 2018 the California Community Choice Association, Commercial Energy of California, Direct Access Customer Coalition/Alliance For Retail Energy Markets and the Energy Users Forum (Joint Parties) filed a Joint Motion to Extend the Procedural Schedule and Request to Shorten Time For Replies (Joint Motion). In the Joint Motion, Joint Parties request an extension of the procedural schedule set by the Scoping Memo and Ruling of the Assigned Commissioner issued on September 25, 2017.

Joint Parties also request that the time for parties to respond to the Joint Motion be shortened to five days.

Rule 11.1(e) of the Commission's Rules of Practice and Procedure states that responses to written motions must be filed and served within 15 days of the date that the motion was served, except as otherwise provided in the Rules or unless the Administrative Law Judge sets a different date.

A shortened response period will help ensure that this proceeding continues to move efficiently toward a Commission decision as soon as possible. Therefore, Joint Parties' request for a shortened response period should be granted.

IT IS RULED that:

1. Responses to the February 7, 2018 Joint Motion to Extend the Procedural Schedule in this proceeding shall be filed and served no later than February 12, 2018.
