Rule 11.6 states:

Motions for extension of time limits established in these rules or in a ruling of an Administrative Law Judge or Commissioner may be made orally, by e-mail, or by letter to the Administrative Law Judge. If other parties to the proceeding are affected by the extension, the party requesting the extension must first make a good-faith effort to ask such parties to agree to the extension. The party requesting the extension must report the results of this effort when it makes its request. Dear Judge Mason:

By this email, Lyft, Inc. moves pursuant to Rule of Practice and Procedure 11.6, for an order extending the time for parties to submit and serve reply briefs to the April 6, 2018 Proposed Decision Authorizing a Pilot Test Program for Autonomous Vehicle Passenger Service with Drivers and Addressing in Part Issues Raised in the Petitions for Modification of General Motors, LLC/GM Cruise, LLC, Lyft, Inc., And Rasier-CA, LLC/UATC, LLC for Purposes of a Pilot Test Program for Driverless Autonomous Vehicle Passenger Service ("Proposed

Decision” or “PD”). The PD raises a number of novel and very complex issues, and Lyft anticipates that many parties will submit opening comments. Pursuant to Rule 14.3(d), reply briefs would be due on Tuesday, May 1, which, Lyft believes, will not allow for adequate time to review, assess, and comment on the various opening comments. Lyft therefore moves that the deadline to submit reply briefs be extended by 10 business days, to Tuesday May 15, 2018.

Consistent with Rule 11.6, Lyft has conferred with certain parties to this proceeding and has inquired through the service list as to whether any party objects to the proposed extension. We can report that both GM and Uber support the proposed extension and, as of this writing, no party has opposed the extension.
