**ADMINISTRATIVE LAW JUDGE'S RULING REVISING PROCEDURAL  
SCHEDULE AND SETTING A DATE FOR A STATUS CONFERENCE**

**Summary**

This ruling revises the procedural schedule in this proceeding and sets a date and time for a status conference.

**Discussion**

On June 8, 2018, Southern California Edison Company (SCE) transmitted to the assigned Administrative Law Judges a request from the parties to modify the procedural schedule in this proceeding. The parties request the following changes:

- 1) Extend the deadline for rebuttal testimony to July 9, 2018 (as opposed to the current deadline of June 18, 2018). This change was supported by all parties except for two parties that sought an earlier deadline of July 6, 2018.
- 2) Begin evidentiary hearings on July 16, 2018 (as opposed to the currently scheduled start date for evidentiary hearings of July 9, 2018). This change was broadly supported by all parties. The Office of Ratepayer Advocates conditioned their agreement on the ongoing progress of settlement discussions. Three other parties' agreement to these terms is conditional on parties providing discovery responses no later than 2:00 p.m. on July 12, 2018, so as to give parties sufficient time to review prior to the beginning of hearings.

Good cause being shown, this ruling adopts the revisions to the procedural schedule requested by SCE. The conditional acceptance of some of the parties is noted. A summary of the revisions to the procedural schedule appears below:

**July 9, 2018** is the new deadline for rebuttal testimony (as compared to the previous deadline of June 18, 2018). The proposed alternative date of July 6, 2018 is rejected given the preponderance of support for a later deadline.

Evidentiary hearings are now scheduled for **July 16, 17, 18, 19, and 20, 2018**. I will remove from the hearing calendar the previously scheduling hearing dates of July 9, 10, 11, 12, and 13, 2018.

This ruling also schedules a telephonic status conference for 1:30 p.m. on July 10, 2018 to discuss logistics for the evidentiary hearings. Parties should be prepared to discuss a schedule for the hearings, estimates of time required for cross-examination, responsibility for maintaining a log of exhibits and other logistical matters. A telephone conference number and instructions will be circulated to the service list before the status conference.

**IT IS RULED** that:

1. The procedural schedule of Application 17-06-030 is modified as outlined above.
2. A telephonic status conference in this proceeding to discuss logistical matters ahead of the scheduled evidentiary hearings is set for 1:30 p.m. on July 10, 2018.
