**Subject:** R.18-10-007 SB 901 OIR - E-Mail Ruling Denying Motion for Evidentiary Hearing (Henricks)

To All Parties:

The Motion to Request an Evidentiary Hearing filed by Ruth Henricks on December 3, 2018 is DENIED, on the following grounds:

1. No direct testimony has been presented, so the scope of the requested cross-examination is not clear.
2. The topic of the requested cross-examination – “why and how California’s three major [electric utilities] have repeatedly failed to comply with GO [General Order] 95” – is utility-specific, historical and factual, and accordingly is inconsistent with the direction of SB 901 to expeditiously implement wildfire mitigation plans.
