ORDER EXTENDING STATUTORY DEADLINE**Summary**

Public Utilities Code Section 1701.5 provides that quasi-legislative proceedings, such as this one, shall be resolved within 18 months of the date on which the scoping memo is issued, unless the scoping memo sets a later date. The Commission may also, upon making a written determination that the deadline cannot be met, including findings as to the reason, issue an order extending the deadline for up to 60 days.

As a result of the issuance of a scoping memo on October 3, 2011, in this proceeding, the 18-month statutory deadline for resolving this consolidated ratemaking proceeding is April 3, 2013.

However, additional time is necessary for the Commission to complete its analysis of the lengthy Smart Grid Deployment Plans filed by Pacific Gas and Electric Company, Southern California Edison Company, and San Diego Gas & Electric Company in this proceeding. This additional time will help the Commission ensure the compliance of these plans with the standards set forth in

D.10-06-047. Therefore, this decision extends the deadline for 60 days, to June 2, 2013.

Background and Discussion

In Application (A.) 11-06-006, San Diego Gas & Electric Company presented a Smart Grid Deployment Plan of 340 pages. In A.11-06-029, Pacific Gas and Electric Company filed a Smart Grid Deployment Plan of 281 pages. In A.11-07-001, Southern California Edison filed a Deployment Plan of 177 pages.

The review of these plans was consolidated into one comprehensive proceeding. Moreover, each plan offers a utility-specific plan to the deployment of its Smart Grid.

Because of the length and complexity of these plans, more time is required to complete the review. For this reason, an order extending the deadline for this proceeding is necessary.

Waiver of Comment Period

Under Rule 14.6 (c)(4) of the Commission's Rules of Practice and Procedure, the Commission may reduce or waive the period for public review and comment of proposed decisions extending the deadline for resolving quasi-legislative proceedings. Accordingly, the otherwise applicable period for public review and comment is being waived.

Assignment of Proceeding

Michael R. Peevey is the assigned Commissioner and Timothy J. Sullivan is the assigned Administrative Law Judge in this proceeding.

Findings of Fact

1. This proceeding to review the Smart Grid Deployment Plans of Pacific Gas and Electric Company, Southern California Edison Company, and San Diego Gas

& Electric Company requires additional time to complete the examination of the lengthy and complex plans filed by each utility.

2. The statutory deadline of this quasi-legislative proceeding is April 3, 2013.
3. A 60-day extension of time to June 2, 2013, is needed.

Conclusions of Law

1. The Commission should extend the deadline in this proceeding to June 2, 2013, as allowed by Pub. Util. Code § 1701.5.
2. In accordance with Rule 14.6(c)(4) the comment period should be waived.
3. This order should be effective immediately.

IT IS ORDERED that the statutory deadline in this proceeding is extended to June 2, 2013.
