RESOLUTION

RESOLUTION ALJ-314 Dismissing Appeal No. K.15-05-021 of Strack Chauffeured Transportation Inc., of Citation No. LAX-976 issued pursuant to Resolution ALJ-187 and Resolution ALJ-299.

SUMMARY

On May 29, 2015, Strack Chauffeured Transportation Inc. (Strack), timely appealed Citation No. LAX-976 issued by the Safety and Enforcement Division, pursuant to Resolution ALJ-187 and Resolution ALJ-299.¹ On June 12, 2015, Strack and the Commission's Safety and Enforcement Division settled the matter, and Strack stated his wish to withdraw the appeal via electronic mail (e-mail).

Strack's request to dismiss the appeal is unopposed. However, Strack's appeal has been assigned to Administrative Law Judge Melanie Darling and been docketed. Therefore, the appeal must be dismissed by resolution. This resolution dismisses with prejudice the referenced Appeal pursuant to Resolution A-4638 and Pub. Util. Code §308(b). Therefore, Citation Appeal K.15-05-021 should be dismissed because there are no issues for the Commission to resolve.

THEREFORE, IT IS ORDERED that the appeal of Strack Chauffeured Transportation Inc. of Citation No. LAX-976 is dismissed with prejudice.
