SAN FRANCISCO, October 25, 2018 - The California Public Utilities Commission (CPUC) is heading to Fresno in November for its Voting Meeting and a series of public forums on consumer issues such as improving public participation in CPUC proceedings, increasing access to affordable energy in disadvantaged communities in the San Joaquin Valley, and reducing service disconnections for customers of natural gas and electric utilities. Also in Fresno on Nov. 9, 2018, from 8:30 a.m. to 4 p.m., Pacific Gas and Electric Company (PG&E), Southern California Edison, San Diego Gas & Electric (SDG&E), and the California Energy Commission will conduct a **workshop on the Electric Program Investment Charge** (**EPIC**), which provides grants for projects at various developmental stages, from lab, to demonstration projects, to market facilitation/adoption. The workshop will provide an update on planned EPIC 3 investments and solicit input on the scoping of the investments. The CPUC requires PG&E, Edison, SDG&E, and the Energy Commission to consult with interested stakeholders no less than twice a year. The workshop will take place at PG&E's Fresno Clubhouse at 2252 S.
