**ORDER CORRECTING ERRORS IN DECISION 12-02-015**

This order corrects nonsubstantive errors in Decision (D.) 12-02-015, Appendix 1 – Attachment B. D.12-02-015 implemented provisions of Senate Bill 1040 relating to the California Advanced Services Fund (CASF) Broadband Infrastructure Grant Account (Grant Account) and Revolving Loan (Loan Account) programs. Appendix 1 of D.12-02-015 consists of updated rules for administering the CASF Grant Account program. Attachment B of Appendix 1 is the “CASF Application Checklist” which is a checklist of items that must be completed for each CASF application.

Subsequent to the issuance of D.12-02-015, we identified certain nonsubstantive errors in the Attachment B “CASF Application Checklist.” Accordingly, an amended version of the Attachment B checklist is appended to this order, incorporating the corrections, as noted below. By this order, we adopt the amended version of the checklist to correct for these nonsubstantive errors in the D.12-02-015 Appendix 1, Attachment B checklist, with deletions and additions as described below:

**List of corrections to Attachment B of Appendix 1:**

1. Item 11: Added text: “by CBG and Zip Code”

2. Item 12: Added two rows to match section V of Appendix 1: “Number of households per CBG,” and “Median household income for each CBG that intersects the proposed project ... ”
3. Item 15: Added text: “by CBG and Zip Code”
4. Item 17 of the checklist: Removed text “source of cost elements” and added “Amount of available funds from each individual funding source”
5. Item 21 of the checklist: Removed text “proposed recurring retail price per MBPS-... ” and added “Proposed (two-year monthly subscription fee for applicant’s proposed broadband service(s)”
6. Item 24 of the checklist: Added “(if providing voice services)”

Pursuant to Commission Resolution A-4661 and Rule 16.5 of the Commission’s Rules of Practice and Procedure, the Commission’s Executive Director is authorized to sign, on behalf of the Commission, orders involving the correction of clerical and other obvious inadvertent errors and omissions in Commission decisions. Accordingly, these corrections to D.12-02-015 are hereby adopted pursuant to Commission Resolution A-4661 and Rule 16.5 of the Commission’s Rules of Practice and Procedure.

### **Findings of Fact**

1. Appendix 1, Attachment B to D.12-02-015 set forth the checklist of items to be completed for use by CASF applicants.
2. The Attachment B checklist incorporated in Appendix 1 of D.12-02-015 included certain nonsubstantive errors.
3. The amended version of Appendix 1, Attachment B, appended to this decision reflects the corrected text for the Attachment B checklist.

### **Conclusions of Law**

1. Pursuant to Commission Resolution A-4661 and Rule 16.5 of the Commission’s Rules of Practice and Procedure, the Commission’s Executive Director is authorized to sign, on behalf of the Commission, orders correcting errors and omissions in Commission decisions.
