NOTICE OF EX PARTE COMMUNICATION

Pursuant to Rules 8.2 and 8.3 of the Commission’s Rules of Practice and Procedure, WesPac Pipelines – Los Angeles LLC (“WesPac – Los Angeles”), the Applicant in this proceeding, files this notice of ex parte communication.

On May 25, 2007, Jose E. Guzman, Jr., attorney for WesPac – Los Angeles, sent a letter to Administrative Law Judge Victor D. Ryerson. A copy of the letter is attached to this notice. In the letter, Mr. Guzman noted the filing of a protest to WesPac – Los Angeles’ application by the City of Gardena and the filing by WesPac – Los Angeles of a reply to the protest. He noted that WesPac – Los Angeles protest asserted that the environmental issues raised in the protest should be directed to the City of Los Angeles, the lead agency under CEQA, and that the issue of WesPac – Los Angeles’ public utility status was a matter of law that could be decided on the existing pleadings in this case or briefed if the ALJ desired. Therefore, Mr. Guzman stated that there was no need for further proceedings before the Commission.

Mr. Guzman concluded the letter by stating that if ALJ Ryerson was inclined to hold a prehearing conference, WesPac – Los Angeles requests that a prehearing conference be held sooner rather than later. Mr. Guzman noted that he would be absent from the state

between June 20th and June 30th and requested that any prehearing conference be held before June 20th.
