
**Re: Status Report on the Settlement of the PacifiCorp 2011

Dear ALJ Wilson:

Pursuant to your Ruling of May 27, 2010 suspending the procedural schedule in the above-captioned proceeding, the Parties, consisting of PacifiCorp, DRA, and the California Farm Bureau Federation, hereby present a Status Report on the progress of settlement efforts in this case. As previously indicated to you via email, on May 27, 2010 the Parties reached final agreement on the last issues in the case. In the intervening time, a Settlement Agreement and a Motion for Approval of the Settlement have been drafted and are undergoing review by the Parties. We note, in particular, that counsel for DRA will not return from an out of state trip until Monday June 14th, so we do not expect the review of the Settlement Agreement and the Motion to be completed until next week. We do believe that the settlement documents and pleadings will be finalized next week, and the Parties hope to file them with the Commission by June 18, 2010.
