STATUS REPORT

Pursuant to the June 18, 2010 Scoping Memo and Ruling of Assigned Commissioner, PacifiCorp hereby submits this status report regarding the formation of the requested trust accounts, development of trustee instructions, and the receipt of permissions required for the proposed surcharge revenues to be deemed tax-free.

On February 22, 2011, the Assigned Commissioner in this proceeding issued the Proposed Decision of ALJ Wilson for comment. PacifiCorp has advised the CPUC Legal Division of the issuance of the Proposed Decision. The Proposed Decision does call for the Commission, through the Executive Director, to create the trusts called for in the Klamath Hydroelectric Settlement Agreement (KHSA). It is anticipated that further discussions between PacifiCorp and the General Counsel and other state agencies involved in the implementation of the KHSA will increase in frequency once the Proposed Decision has been voted upon by the full Commission. This concludes the status report.
