**SUPPLEMENTAL INFORMATION SUBMITTED AT THE REQUEST OF
PRESIDING ADMINISTRATIVE LAW JUDGE**

On January 25, 2011 Central Valley Gas Storage, LLC (U915G) (“Central Valley”), Nicor Inc. (“Nicor”), and AGL Resources Inc. (“AGLR”) (collectively the “Joint Applicants”) filed a Joint Application requesting expedited *ex parte* authorization to transfer indirect ownership of Central Valley to AGLR from Central Valley’s ultimate parent, Nicor, which, will merge with and into a subsidiary of AGLR through a series of proposed transactions. On March 24, 2011, a pre-hearing Conference was held in the above-referenced proceeding before Presiding Administrative Law Judge Amy C. Yip-Kikugawa. During the pre-hearing conference, Presiding ALJ Yip-Kikugawa noted that that Sections 854(b)-(c) of the California Public Utilities Code include specific requirements relating to entities that have gross annual California revenues that exceed \$500 million. Accordingly, the Joint Applicants were asked to file confirmation as to whether AGL Resources Inc. or any of its affiliates, including Sequent Energy Management, L.P., has gross annual California revenues that exceed \$500 million.
