**CHIEF ADMINISTRATIVE LAW JUDGE'S RULING
AMENDING THE PROCEEDING CAPTION ON HER OWN MOTION**

This ruling amends the proceeding caption of Application 10-08-024 to reflect the Commission's approval, in Decision (D.) 10-11-017, of a change in ownership and control.

Sierra Pacific Power Company (Sierra) filed this application on the date indicated above. The application requests that the Commission grant Sierra a permit to construct the Line 625/650 Upgrade Project. D.10-10-017 approved the sale of Sierra's California electric service territory and associated assets to California Pacific Electric Company, LLC (CalPeco). CalPeco completed the acquisition on January 1, 2011 and since that time has been providing electric service to the electric consumers located within its service territory. As a result of the change of ownership, on January 31, 2011, CalPeco filed a Notice of Substitution of Party. D.11-02-015 confirmed assignment of utility identification number U933E to CalPeco.

Therefore, **IT IS RULED** that:

1. The caption in Application 10-08-024 is revised, as set forth above and adopted here.
2. The entry for this proceeding shall be corrected in the Commission's Case Information System, and all future filings from this date shall include the amended caption.
