**ADMINISTRATIVE LAW JUDGE'S RULING  
EXTENDING CONFIDENTIALITY OF  
INFORMATION IN APPENDIX A OF APPLICATION 00-12-017**

Pacific Gas and Electric Company (PG&E) and New Cingular Wireless PCS, LLC (Cingular Wireless), formerly known as AT&T Wireless Services of California, have filed a motion requesting renewal of authority to maintain the confidentiality of certain commercially sensitive information contained in the Master License/Lease Agreement for Antenna Attachments attached as Appendix A to Application 00-12-017. The Commission initially granted confidential treatment of these documents in Decision 02-03-059, and stated that if Applicants' believed that further protection is needed after two years, they may file a motion stating the justification for further confidentiality.

Confidentiality was extended for another two years in a ruling of May 7, 2004.

In the instant motion, PG&E and Cingular Wireless assert that the confidential and commercially sensitive nature of the information contained in the Master License/Lease Agreement is the same today as it was in 2000. The information for which confidentiality is sought includes the terms of the compensation provisions for Cingular Wireless use of PG&E's structure, the term

of the agreement and renewal periods, and equipment locations. There were no responses to the motion. We have granted similar requests to file information under seal and will do so here. Disclosure of the information would alert competing communications providers to the terms of the agreement and affect the business interests PG&E and Cingular Wireless have negotiated.

Therefore, **IT IS RULED** that:

1. The March 30, 2006 motion of Pacific Gas and Electric Company and New Cingular Wireless PCS, LLC (Applicants) to file information under seal is granted for two years from the date of this ruling. During that period, the information shall not be made accessible or disclosed to anyone other than the Commission staff, or on the further order or ruling of the Commission, the Assigned Commissioner, the Assigned Administrative Law Judge (ALJ), or the ALJ then designated as Law and Motion Judge.

2. If Applicants believe that further protection of the information filed under seal is needed, they may file a motion stating the justification for further withholding of the information from public inspection, or for such other relief as the Commission rules may then provide. This motion shall be filed no later than one month before the expiration date of today's protective order.
