**ADMINISTRATIVE LAW JUDGE'S RULING ON RESULTS
OF FIRST PREHEARING CONFERENCE AND SETTING A
SECOND PREHEARING CONFERENCE**

A prehearing conference (PHC) in the above matter was held on August 22, 2006, in San Francisco. Ali Moayed and Jon Larsen appeared for the complainant. Pelle Jensen, Director of Regulatory Affairs, appeared for defendant San Jose Water Company (SJW). The PHC was held to identify the issues in dispute in this case and to set a hearing schedule.

At the PHC the parties agreed to further discuss the issues informally, prior to any evidentiary hearing, in an effort to resolve this complaint. SJW also agreed to provide certain cost data to the complainant as part of these informal discussions.

As discussed at the August 22nd PHC, a second PHC will be held in this matter on October 4, 2006 at the Commission Courtroom, State Office Building, 505 Van Ness Avenue, San Francisco, California 94102, at which time the parties will report on the results and status of their informal discussions. If necessary,

an evidentiary hearing will be held on November 7, 2006. A briefing schedule for the evidentiary hearing will be determined at the second PHC.

Parties desiring expedited or daily transcripts of the second PHC should advise the Chief Hearing Reporter by telephone at 415-703-1473, by September 29, 2006. The attached service is the permanent service list to this proceeding.

IT IS RULED that a second prehearing conference, for the purposes described above, is set in this proceeding for October 4, 2006, at 1:30 PM, and an evidentiary hearing for November 7, 2006, at 10AM, in the Commission Courtroom, 505 Van Ness Ave., San Francisco, CA 94102,
