**ADMINISTRATIVE LAW JUDGE'S RULING  
DIRECTING SERVICE OF APPLICATION ON  
ADDITIONAL PARTIES AND EXTENDING PROTEST PERIOD**

On March 13, 2007, the North American Numbering Plan Administrator (NANPA) submitted its application for relief of the 714 numbering plan area. The application states that available central office codes will be exhausted in the 714 area code in the fourth quarter of 2008. NANPA requests, on behalf of telecommunications carriers operating or contemplating operations in the 714 numbering plan area, an all services distributed overlay relief plan for this numbering plan area.

At Commission staff direction, NANPA served its application on all parties to the local exchange competition proceeding, Rulemaking (R.) 95-04-043/Investigation (I) .95-04-044.

To adequately inform potentially interested parties, NANPA shall serve the application on all cities and counties in the 714 area and, to the extent not

included in the R.95-04-043/I.95-04-044 list, all 714 code and block holders.<sup>1</sup> As provided in Rule 1.9 of the Commission's Rules of Practice and Procedure, a notice of availability may be served in lieu of the actual application. While Rule 1.10 allows for electronic mail service, a reliable electronic mail service list has not yet been established for this proceeding so this method of service shall not be used at this time. NANPA shall file a certificate of service setting forth the names and addresses of all entities that have been served.

The protest period provided in Rule 2.6 shall be extended to June 1, 2007. NANPA shall include a copy of this ruling if it serves full copies of the application. If NANPA serves notices of availability, then the notice shall contain this information.
