ADMINISTRATIVE LAW JUDGE'S RULING GRANTING MOTION REGARDING SELF-GENERATION INCENTIVE PROGRAM IMPACT REPORT

On May 28, 2008, Pacific Gas and Electric Company (PG&E) filed a motion on behalf of the program administrators¹ of the Self-Generation Incentive Program (SGIP) requesting approval of a time extension for submittal of the 2007 Impact Report for SGIP. The current schedule, set forth in a May 18, 2006 ruling in Rulemaking 06-03-004, calls for the Impact Report to be filed on June 16, 2008. The program administrators seek an extension until October 1, 2008.

The program administrators claim an extension is necessary to permit additional data collection needed to complete the report.

I will grant the extension, although reluctantly, because delay of the 2007 Impact Report until October will make it unlikely the Commission can use it to consider program modifications before the start of the 2009 program year. The program administrators have known of the need to complete this report since

May 2006. It is my hope that any problems with data collection are quickly resolved so that future reports can be completed on schedule.

IT IS RULED that the May 28, 2008 motion of Pacific Gas and Electric Company, on behalf of the Self-Generation Incentive Program (SGIP) administrators, is granted to allow an extension for filing of the 2007 SGIP Impact Report to October 1, 2008.
