ADMINISTRATIVE LAW JUDGE'S RULING DETERMINING ENERGY DIVISION SCHEDULE FOR REVIEW OF 2008 INCENTIVE CLAIMS

Decision (D.) 07-09-043 set a schedule for Energy Division to review the utilities' 2008 energy efficiency incentive claims. The schedule for this review is shown in Attachment 7 to that decision. As part of the review, Energy Division was to provide 2008 Verification Reports of costs and installations and services completed by August, 2009.

Ordering Paragraph 8 of D.08-12-059, which modified D.07-09-043 and D.08-01-042 on December 18, 2008, added an additional requirement to the schedule delineated in Attachment 7 of D.07-09-043: "Energy Division shall issue the draft Verification Report via a draft resolution..." Ordering Paragraph 9 of D.08-12-059 added an additional procedural requirement: "Within 30 days of this decision, the assigned Administrative Law Judge shall issue a ruling clarifying how the issuance of Energy Division's verification reports by resolution will be incorporated into the schedule adopted in D.07-09-043."

Energy Division staff issues Draft 2nd Verification Report via Resolution	May 29, 2009
Parties submit comments and reply comments on Draft Resolution	June 15, 2009 and June 29, 2009
Commission adopts Resolution on Energy Division's Final 2nd Verification Report	No Later than August 25, 2009
Investor-owned Utilities (IOUs) submit advice letters for 1st Interim Claim	Within 45 days after Commission adopts Resolution
Protest period on IOUs' advice letters	
Energy Division reviews and prepares Resolution for IOUs' advice letters	November 17, 2009
Parties submit comments and reply comments on Draft Resolution approving 2nd Interim Claim	
Commission adopts Resolution on IOUs' 2nd Interim Claim	December 17, 2009
