Pursuant to Paragraph Two of the December 21, 2009 Ruling of the Assigned Commissioner and Administrative Law Judge Directing Applicants to Amend Application and All Parties to Meet and Confer, Southern California Edison, San Diego Gas & Electric Company, Southern California Gas Company, Pacific Gas and Electric Company, Division of Ratepayer Advocates, Disability Rights Advocates, Consumer Protection and Safety Division, Mussey Grade Road Alliance, and The Utility Reform Network (TURN)¹ submit the following joint status report.

¹ TURN was not included in the December 21, 2009 ruling because it was not a party when the ruling was issued. TURN subsequently filed a motion to intervene in the proceeding. No party opposes TURN's participation in the meet and confer process.

Representatives of the parties met and conferred, in person, on January 27, February 11 and February 22, 2010 at the California Public Utilities Commission's offices. Administrative Law Judge Janet Econome facilitated the meet and confer process as an Alternative Dispute Resolution Neutral. The parties were scheduled to conduct another all-party meet and confer session on March 9, but mutually agreed to postpone that meeting pending further discussions among a subset of the parties. Such discussions have continued, and the parties expect to convene another all-party meet and confer session on a mutually convenient date in April.

All parties agree to continue discussions within the meet and confer process. The parties propose to file a further status report on or before April 30, 2010. This further status report will address whether the parties wish to continue the meet and confer process.
