**ADMINISTRATIVE LAW JUDGE'S RULING CORRECTING  
MARCH 1, 2012 RULING**

This ruling correctly reidentifies Exhibit Nos. 33-A and 33-B and makes related corrections to the First Amended Exhibit List served along with my previous ruling dated March 1, 2012 (March 1 Ruling).

The March 1 Ruling misidentified and then ruled into the record of the above-captioned consolidated proceeding two direct prepared testimonies of two San Diego Gas and Electric Company witnesses, as exhibits into the proceeding record, as Exhibit Nos. 33-A and 33-B.
