Summary: On June 21, 2007, Barbara Barkovich of California Large Energy Consumers Association, a member of the Bilateral Trading Group (BTG) met with Nancy Ryan, advisor to Pres. Peevey in San Francisco. Also present were Mathew Deal, advisor to Pres. Peevey and Andrew Campbell, advisor to Cmmr. Chong. Representatives of BTG's members were also present: Sue Mara, RTO Advisors, Consultant to APS Energy Services and Strategic Energy; Curtis Kebler of J. Aron Company; Brett Franklin of Electricity Oversight Board; Fred Mobasheri of Electric Power Group, Consultant to Division of Ratepayer Advocates (DRA); and Charlyn Hook, counsel for DRA. BTG representatives referred to their May 18, 2007 Pre-Workshop Comments, Track 2 Issues filed in this proceeding, while summarizing why they oppose a centralized capacity market. The representatives explained how such a market will diminish price signals, undermine demand response programs and technology, and why performance penalties are required to ensure customers get the capacity they're paying for. The representatives also discussed BTG's market model as it relates to electricity prices and uses, as well as, jurisdictional issues regarding loss of state authority resulting from a FERC-regulated centralized capacity market.
