This line is needed to expand access to potential windpower development in the Tehachapi area. Recently, SCE signed contracts for more than 1,500 megawatts (MWs) of installed wind capacity in the Tehachapi area. Altogether, the California Independent System Operator's queue for projects seeking to interconnect near Tehachapi exceeds 4,000 MWs. The Antelope-Pardee Transmission Line would include the construction of a new 25.6-mile, 500 kilovolt (kV) transmission line to connect SCE's existing Antelope Substation, located in Lancaster, with SCE's existing Pardee Substation, located in Santa Clarita. Initially, the transmission line would be energized at 220 kV. The project would also include an expansion of the Antelope substation and the relocation of several existing 66 kV transmission lines in the vicinity of the Antelope substation. The Antelope-Pardee 500 kV Transmission Line project is also referred to as "Segment 1 of the Antelope Transmission Project" or "Phase 1 of the Tehachapi upgrades."

To rectify this misappropriation and punish for affiliate transaction violations, the Commission in this decision has reduced rates by \$2,128,800 in Test Year 2006-2007; reduced rate base as of July 17, 2004 by \$4,054,100; refunded to ratepayers \$1,481,100; and fined San Gabriel \$40,000. [6360] I06-03-001 - Related matters. D04-07-034 authorized San Gabriel Valley Water Company (San Gabriel) to increase rates subject to refund depending on the allocation between ratepayers and shareholders from the sales of property, condemnation awards, and inverse condemnation awards. This decision finds that Pub. Util. Code Section 790 should not be applied with respect to the proceeds San Gabriel received related to compensation for contamination and as a consequence San Gabriel retained \$1,570,421 which should have been allocated to ratepayers. To rectify this, the alternate decision has reduced ratebase by \$1,570,421 and recomputed rates back to July 17, 2004, resulting in a minimum refund of \$719,100. Allocation of other sales and awards is deferred pending resolution in R04-09-003. San Gabriel is ordered to pay a fine of \$60,000 for affiliate transaction violations.

This proposed resolution modifies existing Res. L-318 to conform it to the new provisions and modifications of the Public Utilities Code that arose out of the passage of Assembly Bill (AB) 2220, (Chapter 763, Statutes of 2006). Existing procedures allow the Commission's Executive Director to suspend or revoke the operating authority of household goods carriers if the carrier or one of its officers is convicted of certain categories of felonies. AB 2220 expands the number of offenses for which suspension or revocation is merited including various forms of fraud or dishonesty. The statute also allows the Executive Director to act in the event the carrier or an officer of the carrier pleads nolo contendere to one of the named offenses.
