Pursuant to Rules 8.2(c), 8.3 and 8.5 of the Commission's Rules of Practice and Procedure, the Division of Ratepayer Advocates (DRA) files this Notice of an *ex parte* communication.

On February 22, 2010, at approximately 2:45 p.m., DRA representative Danilo Sanchez, DRA Water Branch Manager, and Lisa Bilir, Public Utility Regulatory Analyst V, DRA Water Branch, met with Laura Krannawitter, Advisor to Commissioner Bohn at the Commission's headquarters in San Francisco. The meeting lasted approximately 5 minutes. During the meeting, DRA recommended moving the language "We similarly limit the authorization of such memorandum accounts to the circumstances of this proceeding." from p. 15 of the body of ALJ Grau's Proposed Decision to an Ordering Paragraph. DRA explained that this modification would narrow this authorization in line with this concept outlined in the body of the proposed decision.
