Sara Steck Myers, attorney for GHSC, initiated the communication with Laura  
Krannawitter, water advisor to Commissioner John Bohn. Also present at the meeting  
was Clint Hilderbrand, GHSC General Manager.

Ms. Myers stated that GHSC strongly supported the Proposed Decision of ALJ  
DeBerry granting the certificate of public convenience and necessity (CPCN) requested  
in A.08-08-011 and authorizing GHSC to operate as a Class D sewer public utility  
subject to this Commission's jurisdiction. Ms. Myers and Mr. Hilderbrand noted that  
GHSC in its comments on the Proposed Decision requested two minor modifications to  
clarify the appropriate advice letter tier for establishing rates and memorandum  
accounts.
