- 3. The customer's installation must be such as to effectively separate the fire sprinkler system from that of the customer's regular water service. As a part of the sprinkler service installation there shall be a detector check with by-pass meter or other similar device acceptable to the company which will indicate the use of water. The utility may require a bi-annual test of the detector heck installation at customer cost as a condition of furnishing service. Any unauthorized use will be charged for at the regular established rate for general metered service, and/or may be grounds for the company's discontinuing the fire sprinkler service without liability to the company.
