TO: PARTIES TO DRAFT RESOLUTION EGPB-8

Enclosed is Draft Resolution EGPB-8 of the Consumer Protection and Safety Division addressing the Final Audit Report of Delta Energy Center. It will be on the agenda at the July 30, 2009 Commission meeting. The Commission may then vote on this Resolution or it may postpone a vote until later. The actual audit report will not be available on the website unless and until the Commission makes it public at the July 30, 2009 meeting.

It shall focus on factual, legal or technical errors in the proposed Draft Resolution.
