**NOTICE OF AVAILABILITY**

Draft Resolution T-17127: All certificated Communications carriers, Telecommunications Access for the Deaf and Disabled Administrative Committee members, California Relay Service Advisory Committee members, and Equipment Program Advisory Committee members, California Communications Access Foundation, and the parties of record in I.87-11-031, R.00-05-001 and R.03-03-014.

Draft Resolution T-17128: All certificated Communications carriers, the CHCF-A Administrative Committee and the parties of record in R.01-08-002 and A.99-09-044.

The following resolutions will be on the agenda of the Commission's December 20, 2007 meeting:

- Resolution T-17127, if adopted, will approve a Deaf and Disabled Telecommunications Program (DDTP) Fund Surcharge Rate of 0.20% Effective January 1, 2008.
- Resolution T-17128, if adopted, will approve a California High Cost Fund-A (CHCF-A) Administrative Committee Fund Surcharge Rate of 0.13% Effective January 1, 2008.

The above draft resolutions are available at the Commission's web-site at [www.cpuc.ca.gov](http://www.cpuc.ca.gov). Enter "T17127" for DDTP and "T17128" for CHCF-A in the "Search" field box at the top right corner, and then click search. On December 20, 2007, the Commission may vote on these resolutions, or it may postpone a vote until later. When the Commission votes on a draft resolution, it may adopt all or part of it as written, amend, or modify it, or set it aside and prepare a different resolution. Only when the Commission acts does a resolution become binding on the parties. The conformed resolutions, when adopted by the Commission, will be available at the same website.

Pursuant to Public Utilities (PU) Code 311 (g), the draft resolutions are available for public comments. Comments should be focused on factual, legal, and/or technical errors in the draft resolution. Comments must be limited to five pages in length and shall include a subject index listing the recommendations to the draft resolution, a table of authorities, and an appendix setting forth the proposed revised findings and ordering paragraphs.

If you wish to be served by parties filing opening and reply comments, please inform the Communications Division, Program Management & Implementation Branch, of the California Public Utilities Commission by November 27, 2007, of your request by e-mail to [tch@cpuc.ca.gov](mailto:tch@cpuc.ca.gov). Otherwise, comments on Draft Resolutions T-17127 and T-17128 will be addressed only to the Communications Division as stated below.

The date of submission is the date the comments are received by the Communications Division. Parties must serve a copy of their comments to each requesting party, if any, as set forth on the Commission web-site on the same date that the comments are submitted to the Communications Division. The requesting party list, if any, will be available on the Commission web-site at [http://www.cpuc.ca.gov/PUC/Telco/Public+Programs/FormNotices\\_Public+Program.htm](http://www.cpuc.ca.gov/PUC/Telco/Public+Programs/FormNotices_Public+Program.htm) on November 30, 2007.

Comments must be submitted no later than 4:00 pm on December 5, 2007, (which is 15 days from the date of this mailing). Reply comments must be submitted no later than 4:00 pm on December 11, 2007, (6 days after opening comments are submitted) and shall be limited to identifying misrepresentations of law, fact, or condition of the record contained in the comments of other parties. Replies shall not exceed five pages in length and shall be submitted and served in the same manner as opening comments.

Late-filed opening comments and/or reply comments will ordinarily be rejected. However, in extraordinary circumstances, a request for leave to submit comments or replies late may be filed together with proposed comments/replies. An accompanying declaration under penalty of perjury shall be submitted setting forth all the reasons for the late submission.
